I'd like to start off by saying I'm a train enthusiast from the hayward area, switching between houses near the southern and northern parts of Hayward. I use the Hayward station for trainwatching all the time, but I have used it to board trains before as well. I know there are also nearby commuters using the Capitol Corridor on a daily basis as well; not to mention any travellers or other folks from the area who need to use the local and convenient access point to Amtrak's entire system the Hayward station provides.

One thing I noticed was that construction projects were just completed giving the stations in Hayward and Fremont makeovers, with hayward having recieved a new platform, new pedestrian fences, signage, lightposts, security cameras, etc. If service were totally discontinued to the Hayward and Fremont stations, all that taxpayer money and labor would go to waste.

Also, if trains were rerouted over to the coast sub, passengers transferring over to ACE to get from Fremont to Stockton would have a harder time doing so within Fremont, and it'd cost them more money and time to make that transfer elsewhere. I would also hope that the new ardenwood station actually be constructed if this plan as it was written were to come into fruition, but it still would not directly serve any passengers transferring to ACE or, for that matter, anyone in Hayward at all. I have attempted to use the Ardenwood park & ride lot to ride a bus across the Dumbarton bridge, too, but that little parking lot is ALWAYS packed; even without a train station.

Overall, I am generally opposed to the idea of rerouting all Capitol trains to the coast sub for the above reasons. If any Capitol trains were to be rerouted over to the Coast Sub with the new station having been built, I'd still want the majority of them going over the Niles subdivision to serve the aforementioned communities.

That being said, if I were to make some changes to the plan as it is, I would suggest finding room to make a station somewhere in Hayward on the Coast Sub, and to maybe not use the ardenwood park & ride as the main goal for a station in Fremont due to the issues connecting to ACE. It would be better to see a new station planned not too far south of Control Point Newark (as this is the junction where the Niles and Coast subs meet to head south) potentially very close to Mowry by the Silliman aquatic center. Having the station close to but south of CP Newark would allow access for ACE transfer in fremont while still having Capitol rains run over the Coast Sub. I still wouldn't like to see these changes be made, though, as I literally live a few blocks away from the curent hayward station and I among others use it, for whatever reason we do.

Please pause to reconsider the entire basis of your project. SBC has now become a "budget without a cause", as there is practically no need left for you to fill:

- BART is already serving Berryessa, and will gradually make its way farther into San Jose and Santa Clara.
- BART has more, and more-convenient, stations than you will ever have, complete with parking lots, escalators, and transfer facilities. Many of those stations are near employment centers, shopping centers, and concentrated housing.
- BART has no at-grade road crossings to worry about or to remedy.
- BART riders who want to take a bus across the Dumbarton Bridge can already transfer at Union City and take full advantage of the carpool lane (which buses entering from Ardenwood couldn't reach in the AM rush without special flyover ramps or the truly over-the-top alternatives shown on your webpage). When you find that you need to turn a simple bus stop into some kind of kludgy spaceport, it suggests a problem elsewhere in the design, like ... wrong location.
- BART riders who want to get to OAK (or SFO) have shuttles available just off the BART platforms.

I have had to take the Capitol Corridor from Mountain View via Caltrain to Fremont because the transit connections in the South Bay are so bad.

This project feels like it is trying to compete with an outdated 9 - 5 BART traditional car commuter model complete with park and rides which is insane when the riders are built in in Fremont and Hayward today.

I have lived and worked in Newark and the Ardenwood station area does not adequately complement existing bus services or land uses in the slightest. Nobody would use it, there would be at most 30 people coming from Pacific Commons in the shuttles just a couple years ago. I would like to bring your attention to the ongoing draft EIR public comment period for South Bay Connect (SBC) project (https://southbayconnect.com/resources.html) which is ending on July 15, 2024. I am an Ardenwood resident in District 1 and I served on the Community Working Group (CWG) for SBC, along with other Fremont community members.

Recall that the City of Fremont has adopted a resolution opposing the South Bay Connect Project on November 10, 2020

(https://fremontcityca.iqm2.com/Citizens/Detail_LegiFile.aspx?ID=4203) for the reasons below

The City Council voted to oppose the project at this time and expressed interest in having the project address the following issues in addition to topics typically covered as part of an environmental impact report, such as noise, vibration, air quality, hazardous materials, water quality, vehicle trips, transit service, public services, and land use:

- * location of and service levels of freight trains in Fremont and how changes might affect the Fremont community
- * determination of how the project interrelates to other existing and planned passenger rail services in southern Alameda County, including ACE, BART and Dumbarton corridor transit services along with how the services interconnect at transit hubs in Centerville, Ardenwood, Union City and Newark
- * address the project cost/benefit and priority in light of COVID influenced changes to commute demand, transit use, and telework.

Unfortunately, none of these issues were considered either in EIR or in project scoping. Specifically, during the Oct 2020 communication between Fremont city staff and CCJPA, CCJPA promised the City of Fremont that the EIR would include location of and service levels of freight trains in Fremont and how changes might affect the Fremont community. This is specifically skipped during the EIR.

One strong concern about the draft EIR itself is that for the first time the SBC project is centered around dual track "upgrade" (Section 2.3). This certainly comes as a big surprise to my community as this was never mentioned or communicated during the scoping discussion back in 2020 and in the past 4 years. The SBC Project Management should be more transparent about this change during the draft EIR public comment period, through website, flyer, and mailers. After some digging, it seems that the reason for such a big change from the project scoping in 2020/2021 is to meet the EIR funding deadline. Here I quote the "CAPITOL CORRIDOR FY 2024-25 & FY 2025-26 DRAFT ANNUAL BUSINESS PLAN – MAY 2024" Page 14:

After delays waiting on UPRR for capacity modeling results, the CCJPA determined the most pragmatic approach is to presume a maximum footprint for track infrastructure needed to meet funding deadlines associated with the draft Environmental Impact Report (EIR).

Hence, the SBC project management is actually waiting for UPRR for capacity modeling results which will reflect the original plan (shifting freight to Niles, shifting CC to Coast). Only because such a model is delayed does the SBC project management proceed with the "maximum footprint" EIR. The whole "Alternative E" discussion in the EIR is just a technical way to circumvent this difficulty. This seems inconsistent with the good faith requirement of CEQA as the EIR content is completely different from the actual project plan. This is also ignoring the central concern from the City of Fremont.

Moreover, the City of Fremont has participated in Southern Alameda County Integrated Rail Analysis (SoCo Rail) Study in 2023 (https://mtc.ca.gov/planning/transportation/regional-transportation-studies/southern-alameda-county-integrated-rail-analysis-soco-rail-study), which specifically assigns Union City BART as the East Bay Hub, instead of building a new Ardenwood railway station (a key component of SBC).

We hope the City Council would look into this matter and

- * Invite SBC staff to present in City Council on the draft EIR and explain the above concerns
- * Adopt another opposition resolution if such concerns can not be properly addressed
- * Investigate the way to block the design, EIR and construction of the new Ardenwood railway station to be consistent with the Southern Alameda County Integrated Rail Analysis study recommendation.
